Join OLLI members in viewing the collection of Fleur Bresler at her private residence in Rockville, MD. In 2010, the Renwick Gallery of the Smithsonian American Art Museum exhibited "A Revolution in Wood," featuring 66 pieces donated by Charles and Fleur Bresler. The Smithsonian website declares that the Bresler Collection's "Masterpieces by the field's pioneers, including David Ellsworth, William Hunter, Mark and Melvin Lindquist, Edward Moulthrop, and Rude Osolnik, ... Ron Fleming, Michelle Holzapfel, Hugh McKay, Norm Sartorius, Mark Sfirri, and many others reveal the advent of new techniques, including multi-axis turning, the incorporation of secondary materials, and a strong focus on carving. The Bresler collection illustrates these evolving techniques and aesthetics, which has led to increased use of the term 'wood art' rather than 'wood turning' to describe the medium."
